## Building a Union without barriers

"Everyone has a right to a life without barriers. And it is our obligation, as a community, to ensure persons with disabilities can fully participate in society, on an equal basis with others."

**50.8%** of persons with disabilities are in employment compared to **75%** without disabilities.



**28.4%** of persons with disabilities are at risk of poverty or social exclusion compared to **17.8%** of persons without disabilities.



Only **29.4%** of persons with disabilities attain a tertiary degree compared to **43.8%** of those without disabilities.



**52%** of persons with disabilities feel discriminated against.

## Full participation of people with disabilities: rights, autonomy and equality

87 million persons in the EU have some form of disability. They all have the following rights:



Enjoy EU rights

- Be able to move to another EU country.
- Participate in political elections.



Live independently and autonomously

- · Participate in the labour market.
- · Learn new skills for new jobs.



Participate and be protected from discrimination

- · Receive an education.
- Access justice and legal protection.

## To foster the inclusion of persons with disabilities the Commission will propose several flagship initiatives, for example:



- AccessibleEU will be a knowledge base providing information and good practices on accessibility across sectors.
- Thanks to AccessibleEU persons with disabilities will have better access to transport, buildings, information, audio-visual media and communications.



- Free movement of persons is a right of every EU citizen.
- The Commission will propose a European
  Disability Card recognised by all Member
  States, that will make it easier for persons with
  disabilities to exercise their right to move freely.

## **Working together**

Fulfilling our obligations under the United Nations Convention on the Rights of Persons with Disabilities requires a strong commitment from Member States and EU institutions.

- **Member States** are encouraged to reinforce actions for persons with disabilities, including those launched through this strategy, to make best use of EU funds in a disability inclusive manner, and progress on the implementation of the UN Convention.
- The **European Commission** will reinforce the mainstreaming of disability matters in all EU policies and promote the rights of persons with disabilities globally.
- Persons with disabilities will be part of the dialogue and part of the process.
